We are a self-contained testing organization with all testing support provided in-house including vertical access equipment.



The laboratory is a full-service performance testing accredited facility that hosts project specific mock-ups and an array of exterior wall systems, assemblies, and components. Our laboratory has the ability to accommodate up to five specimens at a time with specimen sizes as large as 40'x40'.
